Founded in 1994, Vitamin Angels is a public health nonprofit working to improve nutrition and health outcomes in underserved settings worldwide. We work directly with local and national organizations, including governments, to offer evidence-based nutrition interventions and technical assistance in support of the most nutritionally vulnerable groups—pregnant women, infants, and young children—who are underserved by existing systems.

We collaborate with over **1,200 partners** to reach more than **72 million women and children** in **65 countries annually**.





# LETTER FROM THE PRESIDENT

2023 was an incredible year. By focusing on nutrition solutions that are both scalable and sustainable, we were able to take our work to a new level, reaching more women, infants and children in the US and in 65 countries around the world. A key to our success has been strengthening our collaborative and evidenced-based approach.

Last year, Vitamin Angels made remarkable progress in enhancing critical partnerships with governments, NGOs, and academic institutions to influence and improve health systems at scale. Much of our work focused on the introduction and expansion of national multiple micronutrient supplementation (MMS) programs and policies by raising awareness, building consensus, implementation research, and assistance with

developing, strengthening, and monitoring effective strategies for service delivery.

Additionally, as the global demand for MMS increases, Vitamin Angels saw the need for filling in the gaps in product supplies and helping to address manufacturing challenges, thereby advancing an effective MMS supply strategy at the national, regional, and global levels.

As we reflect on an impactful 2023 and look forward to the years ahead, it is clear that Vitamin Angels is now embarking on another period of dynamic growth, resulting in exciting new opportunities. Last year we impacted 72 million underserved women, infants, and children worldwide. We have a new goal to double our impact to reach 140 million women and children annually by 2033. By collaborating with local stakeholders, national governments, academic institutions, and other trusted public health organizations, we are making great strides in building a supportive environment for improving maternal, infant, and young child nutrition globally.

We cannot do this important work alone. Our deepest gratitude goes out to each and every one of you, our partners and supporters. Together, we are uplifting and amplifying a global community of voices advocating for maternal and child health and bringing a more equitable world within reach.

# **WHY WE EXIST**


Vitamin Angels envisions a world where everyone, everywhere, has a chance to fulfill their potential.

# **EVIDENCED-BASED NUTRITION INTERVENTIONS**

We work with local and national stakeholders—including governments—to coordinate the introduction or strengthening of evidence-based nutrition interventions for underserved pregnant women, infants, and children, such as **vitamin A supplementation (VAS)** and **deworming treatment** for children up to age five, and **multiple micronutrient supplementation (MMS)** for pregnant women. Additionally, we are working to expand the depth and breadth of our work by piloting programs and materials that promote optimal **infant and young child feeding (IYCF)**.

#### **MMS**

During pregnancy, nutrient demands increase to accommodate the rapid growth and development of the pregnant person and her offspring, and sometimes—particularly in low-resource settings—diet alone is not enough to meet these demands. Nutrient deficiencies during pregnancy can lead to adverse pregnancy and birth outcomes. To address malnutrition in pregnancy, Vitamin Angels provides UNIMMAP MMS', which have been shown to address micronutrient deficiencies in pregnancy and have a significant and positive impact on pregnancy and birth outcomes. We also offer Social and Behavioral Change (SBC) interventions to improve MMS uptake and adherence, and maternal diet quality.

\*UNIMMAP MMS, a specific formulation of the supplement commonly known as prenatal vitamins and minerals.





# VAS+D

To build strong immune systems, reduce illness, and support growth, we work with local community-based partners to deliver vitamin A and deworming treatment to children under 5. Two doses of vitamin A every year during early childhood supports healthy immune systems, promotes growth, prevents blindness, and improves child development overall. # **IYCF & SUPPLEMENTARY FEEDING**

To build a more comprehensive package of maternal and young child nutrition interventions, Vitamin Angels has begun to conduct research and develop and test behavior change communication strategies for infant and young child feeding (IYCF) programs including breastfeeding and complementary feeding, as well as supplementary feeding programs to address food insecurity. Each program reduces the risk of childhood infection and promotes optimal health and development.

# **TECHNICAL ASSISTANCE**

Vitamin Angels uses implementation science (IS) to help translate evidence-based nutrition interventions to support pregnancy, infant, and young child nutrition programs. IS provides the systematic approach and tools needed to introduce and improve the implementation and impact of policies and programs. Concurrently, we offer learning solutions for our implementing partners, conduct monitoring and evaluation, and provide supply chain solutions. We work in coordination with governments, local stakeholders, other NGOs, and global manufacturers and suppliers to build a supportive ecosystem to reach those who would not otherwise be reached by existing systems.



#### **LEARNING SOLUTIONS**

To support our program partners in delivering evidence-based nutrition interventions to women and children in their communities, we offer an array of educational materials, training courses, videos, and resources.

#### **MONITORING & EVALUATION**

Our M&E efforts consist of providing program partners with recordkeeping and reporting tools, organizing on-site monitoring visits, and conducting regular coverage surveys. Vitamin Angels leverages M&E to enable continual improvement of our programs and practices.

We work in coordination with governments, manufacturers, NGOs, and other stakeholders to fill gaps in product supplies, address local, regional, and global supply chain issues, and conduct research and consensus-building for sustainable supply chain solutions.

# VITAMIN ANGELS DOMESTIC WORK

In 2023, Vitamin Angels worked in all **50 states** and Puerto Rico, connecting **610,726** pregnant women and their babies with MMS.

In the US, Vitamin Angels partners with over

350 organizations, including WIC clinics,
Federally Qualified Health Centers (FQHCs),
and Health Departments throughout the US
and Puerto Rico. We provide MMS and technical
support to these partners, who then distribute
MMS to women of reproductive age. Additionally,
we are working to expand the breadth of our
work by piloting materials to support MMS
counseling and collaborating with key partners
to conduct formative research on breastfeeding
and to support the development of supplemental
feeding programs for pregnant women and
young children.








# **FINANCIALS**
